a) Architectural Costings Update

Early Class D estimates have been reviewed. It is likely cost prohibitive to create an addition onto the building and so the project will likely be scoped to the current footprint with the focus being major internal upgrades and a new entrance. Costs are running in the \$6-\$8 million range. The final Class D and full initial report will likely be ready for the November Board meeting.

b) Update from Clerks on timing of Board Application/Nomination Process Change

Current vacancies for Library Board nominations closed Oct 6 with intent for Council to fill vacancies Oct 21. Clerks recommend we continue this process such that the subsequent appointment process may follow the new guidelines. Clerks hoping to have this recommendation before Council in November for any alterations to by-laws that may be necessary.

c) Capital Budget Adjustment

Positive discussions with City Admin regarding our budget request. City Admin asked that we make a minor adjustment of approximately \$16,000 to our request to better align with spending targets.
